NOTIFICATION

The following list contains the names of candidates found suitable on the basis of the result of the Objective Type (OMR Valuation) Test held on 18.05.2013 and the verification of original documents of the candidates included in the Probability List published on 19.03.2014 for selection to the post of TRADESMAN (S.M. LAB) on **Rs.4990-7990/-(PR)** in **Technical Education Department in Pathanamthitta District** (Category No. 359/2007) for which notification for selection was published in the Gazette dated 31.10.2007 arranged in the order of merit. **This Ranked List is brought into force with effect from 28.04.2014.**

The List will be in force for a period of one year provided that the said list will continue to be in force till the publication of a new Ranked List after the expiry of a minimum period of one year or till the expiry of three years whichever is earlier. Candidates from this list will be advised for appointment in accordance with the rules and orders regarding reservation and rotation as amended from time to time, if applicable, against vacancies reported to the Commission during the pendency of this list. As the advice for appointment depends on the occurrence of vacancies, there is no guarantee that all the candidates included in this list will secure appointment. The candidates remaining in this list at the time of cancellation will have no claim at all for appointment on the basis of the inclusion of their names in the list.

Entries put in column 4 (community) are based on the communities specified by the candidates in their application forms and proved by them with necessary documents. The candidates whose communities have not been correctly noted in the list as proved by them in their application should intimate the fact to the District Officer, KPSC District Office, Pathanamthitta within 1 (One) month from the date of publication of the Ranked List to be get the benefit of the reservation with they are entitled to. In the absence of timely information regarding discrepancies if any the candidates will be advised as incorporated in this list.

NOTE I:-

Candidates who wish to obtain a photocopy of their OMR answer sheet (Part A & B) relating to this selection shall remit a fee of **Rs.200/- (Rupees Two Hundred only)** by way of chalan in any of the Treasuries in the State under the Head of Account **0051-PSC-800-State PSC-99 Other receipts**. The duly filled up application in the prescribed form (available from the Commission's Website www.keralapsc.gov.in) along with the original chalan should be submitted to the **District Officer, KPSC District Office, Pathanamthitta** within 45 days from the date on which the Ranked List is brought into force. A copy of the answer sheet will be issued only once to a candidate. Copies of OMR sheet invalidated due to any defect will not be issued. Candidates are prohibited from applying for a copy of answer sheet which is not their own, and legal proceedings will be initiated against those who do so. The last date for receipt of applications is 12.06.2014. Applications received after the prescribed date will be entertained.

NOTE II :- A period of 45 days time to apply for rechecking of Answer Scripts will be allowed to candidates with effect from the date on which this Ranked List is brought into force. The candidates can avail only one chance.

Applications for rechecking/obtaining photocopy of answer scripts should be submitted in the prescribed form available free of cost from the enquiry sections of the various offices of the Commission or its photocopy or downloaded and printed in A4 size paper from the Commission's website www.keralapsc.gov.in or photocopied there from. Applications submitted in any other manner will not be considered.

The applications for Re-checking, along with original chalan receipt for the prescribed fee of Rs.50/- under the head of account "0051-PSC 105 State PSC 99 - Examination Fee", addressed to the **District Officer, Kerala Public Service Commission, District Office, Pathanamthitta** should reach the office on or before **12.06.2014**. Applications for rechecking received after the stipulated time will not be entertained and fee once remitted will not be refunded. In the case of candidates who sent applications for rechecking in the prescribed form within the prescribed time limit enclosing original chalan receipt as stated above, the marks awarded will be rechecked and the result of the rechecking will be intimated to the candidates from this office.

NOTE III :-

"Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/Central Government with signature, name, designation and Office Seal. The request for relinquishment received within 15 days from the date of publication of Ranked List will be honoured against the requisitions of vacancies that are pending with the Commission upto the finalisation of Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition based on which he/she is to be advised".
