The printout of the answer sheet will be issued only once to a candidate. Printout of answer sheets invalidated due to any defect will not be issued. Candidates are prohibited from applying for printout of the answer sheet which is not their own, and legal proceedings will be initiated against those who do so.

Note (3) : Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/Central Government with signature, name, designation and office seal.
