NOTIFICATION

The following is the Ranked list containing the names of candidates found suitable on the basis of the Written Test held on **22.10.2011** and the verification of original documents of candidates included in the probability list published on **06.10.2012** for the post of **L.D.CLERK (KANNADA AND MALAYALAM KNOWING)** on **Rs.5250-8390 (PR)** (Category No. **138/2008**) in the **VARIOUS DEPARTMENTS** in **KASARAGOD DISTRICT**, arranged in the order of merit. This Ranked List is brought into force with effect from **01.02.2013**.

The Ranked list will be in force till the publication of a new ranked list after the expiry of a minimum period of one year or till the expiry of three years whichever is earlier. Candidates from this list will be advised for appointment in accordance with the rules and orders regarding reservation and rotation as amended from time to time, if applicable, against vacancies reported to the Commission during the pendency of the list. As the advice for appointment depends on the occurrence of vacancies, there is no guarantee that all the candidates included in this list will secure appointment. The candidates remaining in this list at the time of cancellation will have no claim at all, for appointment on the basis of the inclusion of their names in the list.

According to the existing procedure, revaluation of answer script is not allowed. But the answer scripts will be rechecked, if the candidates apply for the same along with a chalan receipt for the prescribed fee of Rs.50/- (Rupees fifty only)remitted in any one of the Treasuries in the State under the Head of Account "**0051-PSC-105 State PSC-99 Examination Fee**".

Applications for rechecking of answer scripts should be submitted in the prescribed form available free of cost from the Enquiry sections of the various offices of the Commission or its photocopy or downloaded and printed in A4 size paper from the Commission's website www.keralapsc.gov.in or photocopied therefrom. Applications

submitted in any other manner will not be considered. Applications for rechecking of invalidated answer script will not be entertained.

Valid applications for re-checking of the answer script addressed to **District Officer, KPSC District Office, "Tiger Hills", Municipal Office Road, Pulikkunnu, Kasaragod – 671121** shall reach this office within 45 days from the date on which the Ranked List has come into force. The last date for receipt of applications for rechecking of the answer script is **18.03.2013**. Applications for rechecking received after the prescribed time limit and not in the prescribed form will not be entertained. The fee once remitted will not be refunded on any account.

Entries put in Column 4 are based on the communities specified by the candidates in their application form and proved by them with necessary documents. The candidates whose communities have not been correctly noted in the list as proved by them in their applications should intimate the fact to the District Officer, KPSC District Office, Kasaragod within one month from the date of publication of the list, to get the benefit of reservation to which they are entitled to. In the absence of timely information regarding discrepancies, if any, the candidates will be advised as incorporated in the list.
