Candidates are prohibited from applying for printout of the answer sheet which is not their own, and legal proceedings will be initiated against those who do so.

The request for relinquishment received within 15 days from the date of publication of ranked list will be honoured against the requisitions of vacancies that are pending with the Commission up to the finalization of the Ranked list.
