Applications

submitted in any other manner will not be considered. Candidates who wish to obtain a Photocopy of their OMR answer sheet (Part A and Part B) relating to this selection shall remit the fees of Rs.200/- (Rupees Two hundred only) in any one of the Treasuries in the State by chalan under the Head of Account "0051-PSC-800-other receipts 99 - other receipts". A copy of the answer sheet will be issued only once to a candidate. Copies of OMR answer sheets invalidated due to any defect will not be issued. Candidates are prohibited from applying for copy of answer sheet which is not their own and legal proceedings will be initiated against those who do so.
