Note 1 Candidates who wish to obtain a photocopy of their OMR answer sheet (Part A & Part B) relating to the selection shall remit the fee of Rs. 200 (Rupees Two Hundred only) in any of the Treasuries in the State (Head of account 0051 – PSC – 800 – State PSC – 99 other receipts). The duty filled in application in the prescribed form (available from the Commission Website www.keralapsc.gov.in) along with the original chalan receipt should be submitted to the District Officer, Kerala Public Service Commission District Office, Malappuram within 45 days from the date on which this ranked list is brought into force, ie, on or before 10.02.2014. Copy of the answersheet will be issued only once to a candidate. Candidates are prohibited from applying for a copy of an answer sheet which is not their own, and legal proceedings will be initiated against those who do so. The last date for receipt of application is 10.02.2014. Applications received after the prescribed date will not be entertained.

Note 2 A period of 45 days time to apply for rechecking of answer scripts will be allowed to candidates with effect from the date of which this Ranked list is brought into force. The candidates can avail only one chance.

“ Applications for rechecking of answerscripts along with original chalan receipt for the prescribed fee of Rs. 50/- should be submitted in the prescribed form available free of cost from the Enquiry Sections of the various offices of the Commission or its photocopy, or downloaded and printed on A4 size paper from the Commission’s Website www.kerala.psc.gov.in or photocopied there from. Applications submitted in any other manner will not be considered”

The applications for rechecking along with original chalan receipt fro the prescribed fee of Rs. 50/- (Rupees Fifty Only) under the head of account “0051 – PSC 105 State PSC 99 – Examination Fee”, addressed to the District officer, Kerala Public Service Commission, District Office, Malappuram should reach the office on or before 10.02.2014. Applications for rechecking received after the stipulated time will not be entertained and fee once remitted will not be refunded.
