The following list contains the names of candidates found suitable on the basis of the result of the Objective Type (OMR Valuation) Test held on 03.03.2012 for selection to the post of **LOWER DIVISION CLERK (NCA Recruitment for SC)** on Rs.5250-8390/-(PR) in **VARIOUS Departments** in Kottayam District (Category No.438/2009) arranged in the order of merit. The Ranked List is brought into force with effect from **04.02.2014**. The Ranked List will be in force until the candidates are advised and appointed against the vacancies earmarked for **SC community**, but remain unfilled due to the paucity of candidate during the currency of the Ranked List published for the post on 01.01.2006 in Kottayam district.

The candidates who have secured **61 (Sixty One)** marks and above in the Objective type (OMR) Test held on **03.03.2012** are included in the Ranked List.

According to the existing procedure, re-valuation of answer scripts is not allowed. Rechecking of marks will be done on payment of Rs.50/- (Rupees fifty only). The fee should be remitted in any one of the Treasuries in the State under the Head of Account "0051 PSC 105 State PSC 99 Examination Fee". Applications for rechecking of answer scripts should be submitted in the prescribed form available free of cost from the enquiry sections of the various offices of the Commission or downloaded and printed in A4 size paper from the Commission's website www.keralapsc.gov.in or photocopied therefrom. Applications submitted in any other manner will not be considered. The applications for rechecking along with the original chalan receipt should reach the District Officer, KPSC District Office, Kottayam within 45 days from the date on which this Ranked List is published by the Kerala Public Service Commission. The fee once remitted will not be refunded on any account.

Candidates who wish to obtain a photocopy of their OMR answer sheet (Part A & Part B) relating to this selection shall remit a fee of Rs.200/- by way of chalan in any of the Treasuries in the State under the **Head of Account 0051-PSC-800-Other receipts-99 -Other receipts**. The duly filled up application in the prescribed form (available from the Commission's Website <u>www.keralapsc.gov.in</u>) along with the original chalan should be submitted to the **District Officer**, **KPSC District Office**, **Kottayam**. Copy of the answer sheet will be issued only once to a candidate. Copies of OMR sheet invalidated due to any defect will not be issued. Candidates are prohibited from applying for a copy of answer sheet which is not their own, and legal proceedings will be initiated against those who do so.

Valid applications for re-checking/obtaining photocopy of Answer Sheet addressed to **District Officer**, **KPSC District Office**, **Kottayam** shall reach this office within 45 days from the date on which the Ranked List has come into force (ie. the date on which the Ranked List has been approved by the Commission)

The last date for receipt of applications for re-checking/obtaining photocopy of Answer Sheet is 20.03.2014. Application for re-checking/obtaining photocopy received after the prescribed time limit and not in the prescribed form will not be entertained.
