NOTIFICATION

The following list contains the names of candidates found suitable on the basis of the result of the Objective Type (OMR Valuation) Test held on 05-10-2012 and the verification of original documents of candidates included in the probability list published on 27/ 12/2012 for the post of Villageman (Special Recruitment for Physically Disabled persons belonging to Partially Blind, Partially Deaf and Orthopaedically Handicapped (Upper Extremities (Minor) Lower Extremities) on Rs. **8730 - 13540/-** in **Revenue Department in Kozhikode District** for which notification for selection was published in the Gazette dated 30-04-2012 arranged in the order of merit. This Ranked List is brought into force with effect from 02-01-2013.

The Ranked List will be in force for a minimum period of one year provided that the said list will continue to be in force till the publication of a new Ranked List after the expiry of a minimum period of one year or till the expiry of three years whichever is earlier. Candidates from this list will be advised for appointment in accordance with the rules and orders regarding reservation and rotation as amended from time to time, if applicable, against vacancies reported to the Commission during the pendency of this list. As the advice for appointment depends on the occurrence of vacancies, there is no guarantee that all the candidates included in this list will secure appointment. The candidates remaining in this list at the time of cancellation will have no claim at all for appointment on the basis of the inclusion of their names in the list.

According to the existing procedure, revaluation of answer script is not allowed. But the answer scripts will be rechecked if the candidates apply for it along with a chalan receipt for the prescribed fee of Rs. 50/- (Rupees Fifty only) remitted in any one of the Treasuries in the State under the Head of Account "**0051 PSC 105 STATE PSC- 99 EXAMINATION FEE**". The application for re-checking with the original chalan receipt should reach the **District Officer, KPSC District Office, Civil Station, Kozhikode – 20** within 45 days from the date on which this Notification is officially released by the Public Service Commission ie, on or before 15/02/2013. Application for re-checking received after the prescribed time limit will not be entertained. The fee once remitted will not be refunded.

Applications for re-checking of answer scripts should be submitted in the prescribed form available free of cost from the Enquiry Sections of the various Offices of the Commission or its photocopy or downloaded and printed in A4 size paper from the Commission's website www.keralapsc.org or photocopied there from. Applications submitted in any other manner will not be considered. Applications for re-checking received from candidates whose answer scripts have been invalidated will not be considered. .

Candidates who wish to obtain photocopies of their OMR answer script (Part A & Part B) relating to this selection should remit the prescribed fee of **Rs.200/-(Rupees Two hundred only)** in any of the Treasuries in the State under the **Head of Account: "0051-PSC-800 Other Receipts-99-other receipts"**. The duly filled in application in the prescribed form (available from the Commission's website www.keralapsc.org) along with the original chalan should be submitted to **the District Officer, Kerala Public Service Commission District Office, Civil Station, Kozhikode- 20** within 45 days on the date of publication of this Ranked List ie, on or before 15-02-2013. The application received after the prescribed time limit will not be entertained. The Fee once remitted will not be refunded. A copy of an answer sheet will be issued only once to a candidate. Copies of OMR answer sheets invalidated due to any defect will not be issued. Candidates are prohibited from applying for a copy of an answer sheet which is not their own, and legal proceedings will be initiated against those who do so.

Entries put in column 4 (community) are based on the communities specified by the candidates in their applications and proved with necessary documents. The candidates whose communities have not been correctly noted in the list as proved by them in their applications should intimate the fact to the District Officer, KPSC District Office, Kozhikode within one month from the date of publication of the list, to get the benefit of reservation to which they are entitled to. In the absence of timely information regarding discrepancies, if any, the candidates will be advised on the basis of communities specified in the list.

The candidates who have obtained 76 marks and above in the Objective Type (OMR valuation) Test held on 05-10-2012 have been included in the Main List of the Ranked List.
