The candidates belonging to the Other Backward Classes, included in the Short List except SC/ST candidates are required to produce Non-Creamy Layer Certificate as per G O(P) No.81/2009/SC/ST DD dated 26/09/2009 along with other documents. Such candidates in the Main List who fail to produce the required Non Creamy Layer Certificate will not be entitled to the benefit of Community reservation and will be considered as open competition candidates. As regards to such candidates in the Supplementary Lists of Other Backward Classes, their register numbers will be deleted from the Short List without further notice, if they fail to produce the Non-Creamy Layer Certificate. SC/ST candidates shall produce caste certificate obtained from Revenue Authorities not below the rank of Tahsildar as specified in Kerala Gazette along with other documents at the time of verification
  - 05. The place, date and time of practical test will be intimated in due course.
  - 06. Candidates whose register numbers are not included in the Short List may refer to the notification No. ER II (2) 6153/13/EW Dt.22.05.14 showing the details of invalidated scripts.
- 07.According to the existing procedure, revaluation of answer scripts is not allowed. But answer scripts will be rechecked and photocopy of the answer scripts will be issued after the publication of the Ranked List.
