The details will be published along with the Ranked List. Copy of Answer Script of OMR test will also be issued to those candidates who apply for the same remitting the prescribed fee after the approval of the Ranked List

- 8) As sufficient number of candidates with training qualification are available, the list of untrained candidates has not been prepared.
