SC/ST candidates shall produce caste certificate obtained from Revenue Authorities not below the rank of Tahasildar as specified in Kerala Gazette, along with other documents.

Note (5) : The date & time of certificate verification and interview will be intimated in due course.

Note (6) : As per notification ER VII (3) 9466/13/EW dated 23/06/2014, answer scripts of no candidates are invalidated for HSA (Mathematics) NCA – LC/AI
