- 6) Candidates may refer to the notification No.ER VI (2) 8811/13/EW dated 01/07/2014 showing the details of invalidated scripts.
- 7) According to the existing procedure, revaluation of answer scripts is not allowed. But answer scripts will be rechecked and photocopy of the answer scripts will be issued after the publication of the Ranked List. The details will be published in the Ranked List notification.
