Candidates whose Register Numbers included in the Short List are directed to send self attested copies of documents to prove their claims made in the application ie, qualification, date of birth, community and other benefits, if any, to which they are entitled, to The Regional Officer, Kerala Public Service Commission, Ernakulam within 15 days from the date of publication of this Notification.

SC/ST candidates included in the Short List are required to produce 2 (two) copies of Community Certificate issued by the Revenue Authority for producing before the PSC and the candidates belonging to Other Backward Classes included in the Short List are required to produce Non Creamy Layer Certificate as per GO(P) No.81/09/SC/ST DD Dated 26/09/2009 along with the other documents mentioned above. Such candidates in the Main List who fail to produce required community certificate/non creamy layer certificate will not be entitled to the benefit of community reservation and will be considered as Open Competition candidates. The date, time and place of interview will be intimated in due course.

According to the existing procedure, revaluation of answer scripts is not allowed. But candidates can apply for rechecking/photocopy of their answer scripts within 45 days from the publication of the Ranked List for the post. Detailed instructions will be found in the Ranked List notification for this post.
