Note 4: SC/ST candidates included in the Short List are required to produce 2 copies of the Community Certificate issued for production before the 'Kerala Public Service Commission'.

The candidates belonging to other Backward Classes included in the short list, are required to produce Non Creamy Layer Certificate as per G.O.(P)No.81/2009/SCSTDD dated 26.09.2009 shall produce the same along with the other documents mentioned above. Such candidates in the Main List who fail to produce the above mentioned community/Non - Creamy layer Certificate will not be entitled to the benefit of community reservation and will be considered as open competition candidates if otherwise eligible.

**The date, time and place of interview will be intimated in due course.**

According to the existing procedure, revaluation of answer script not allowed. But candidates can apply for rechecking/photocopy of their answer scripts within 45 days from the publication of the Ranked List for the post. Detailed instructions will be published in the Ranked List notification for this post.
