Candidates belonging to SC/ST included in this list shall produce community certificate obtained from the revenue officer not below the rank of Tahsildar.

Note :- (6) Candidates belonging to Other Backward Classes included in this list who are required to produce Non – Creamy Layer Certificate as per G.O (M S) No: 5/2014/SC/ST/DD dated 31.01.2014 shall produce the same along with the other documents mentioned above at the time of verification of original documents.
