Such candidates in the Main List who failed to produce the required Community Certificate/Non Creamy Layer Certificate will not be entitled to the benefit of community reservation and will be considered as Open Competition candidates and such candidates who are included in the Supplementary lists will not be considered for the selection if they failed to produce NCLC/CC as the case may be.

The date, time and place of interview will be intimated in due course.

According to the existing procedure, revaluation of answer script is not allowed. But candidates can apply for rechecking/photocopy of their answer script after publication of the Ranked List for the post. Detailed instructions will be found in the Ranked List notification for this post.

Copy of the answer scripts of the OMR test held on 28.12.2012 will be issued to those candidates who apply for the same remitting the prescribed fee after publication of the Ranked List.
