SC/ST candidates included in the Short List are required to produce 2(two) copies of Community Certificate issued by the Revenue Authority for producing before the Public Service Commission and the candidates belonging to Other Backward Classes included in the Short List, who are required to produce Non Creamy Layer Certificate as per G.O(P) No.117/08/SC/ST/DD dated 19.12.2008 or

G.O(P)No.81/09/SC/ST/DD dated 26.09.2009 along with the other documents mentioned above. Such candidates in the Main List who fail to produce the required Community Certificate/Non Creamy Layer Certificate will not be entitled to the benefit of community reservation and will be considered as Open Competition candidates. The date, time and place of interview will be intimated in due course.

According to the existing procedure, revaluation of answer scripts is not allowed. But candidates can apply for rechecking/photocopy of their answer script after publication of the Ranked List for the post. Detailed instructions will be found in the Ranked List notification for this post.
