Note 5: Candidates included in the Short List are required to produce 2 copies of Community Certificate issued by the Revenue Authority for producing before the Public Service Commission. The date, time and place of interview will be intimated in due course.

According to the existing procedure, revaluation of answer scripts is not allowed. But candidates can apply for rechecking of their answer scripts after publication of the Ranked List for the post. Detailed instructions in this regard will be found in the Ranked List notification for the post.

Copy of the answer scripts of the OMR test held on 12.04.2012 will be issued to those candidates who apply for the same remitting the prescribed fee after publication of the Ranked List.
