Note:- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) The Candidates included in the Short List shall produce Community Certificate as in the form given in the Kerala Gazette obtained from Tahsildar along with other documents at the time of certificate verification. The candidates who fail to produce the required community certificate will not be included in the Ranked List.

Note :- (7) Copy of answer scripts of the OMR Test held on **14/10/2014** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No : **ER VII(2) 1826/15/EW DATED 03/09/2015**.
