  - (2) The Short List is prepared based on the details furnished by the candidate in the application and subsequent claims made will not be entertained at any stage. Candidates who secured 22.67 marks and above in OMR Test are included in the Main List.
  - (3) The candidates whose Register Numbers are included in the short List are directed to upload scanned copies of the original documents to prove their claims made in the applications ie; Qualifications, Experience, date of Birth, Community and other benefits, if any, in their profile before One Time Verification of documents.
  - (4) The place, date and time of verification and interview will be intimated in due course.
  - (5) The candidates belonging to other backward classes included in the short List are required to produce Non-Creamy Layer Certificate as per G O(P) No:81/09/SC/ST/DD dated 26.09.2009 shall produce the same along with other documents mentioned above or as and when called for. Such candidates in the Main List who fail to produce the required Non-Creamy Layer Certificate will not be entitled to the benefit of Community reservation and will be considered as Open Competition candidates. As regard to such candidates in the Supplementary Lists of Other Backward Classes, their Register Numbers will be deleted from the Short List without further notice, if they fail to produce the Non Creamy Layer Certificate.

- (6) adidates whose Register Numbers are not included in the Short List may refer to the invalidated Notification No.ERII(3)5619/14/EW dated 05.05.2015 showing the details of scripts.
- (7) According to the existing procedure, revaluation of answer scripts is not allowed. But candidates can apply for rechecking of their answer scripts only after publication of the Ranked List. The details will be published along with the Ranked List.
