The candidates belonging to Other Backward Classes included in the Short List, are required to produce Non Creamy Layer Certificate as per G.O(P)No.81/09/SC/ST/DD dated 26.09.2009 shall produce the same along with the other documents mentioned above. Such candidates in the Main List who fail to produce the required Community Certificate/Non Creamy Layer Certificate will not be entitled to the benefit of community reservation and will be considered as Open Competition candidates if otherwise eligible.
