The candidates belonging to Other Backward Classes included in the Short List, who are required to produce Non Creamy Layer Certificate as per G.O(P)No.81/09/SC/ST/DD dated 26.09.2009 shall produce the same along with the other documents mentioned above. Such candidates in the Main List who fail to produce the required Community Certificate/Non Creamy Layer Certificate will not be entitled to the benefit of community reservation and will be considered as Open Competition candidates if otherwise eligible.

The date, time and place of interview will be intimated in due course.
