## **NOTIFICATION**

The following is the list of candidates found suitable by the Commission on the basis of the Objective Type (OMR) Test held on **07.01.2017** for selection to the post of **Laboratory Assistant (SR for SC/ST and ST only)** on Rs.8960-14260/- in **Kerala Higher Secondary Education Department in Alappuzha District** and arranged in the order of merit. A common OMR Test was held on 07.01.17 thus marks secured by candidates included in the Ranked List was hidden. The Ranked List is brought into force with effect from **05.12.2018**.

The Ranked List will remain in force till the publication of a new Ranked List after the expiry of a minimum period of one year or till the expiry of three years whichever is earlier. Candiates from this list will be advised for appointment in accordance with the rules and orders regarding reservation and rotation as amended from time to time, if applicable, against vacancies reported to the Commission during the pendency of the list. Candidates against vacancies reported exclusively for Scheduled Tribes will also be advised from this list and only in the absence of Scheduled Tribes candidates in this list, fresh notification for vacancies reserved exclusively for Scheduled Tribes will be issued. As the advice for appointment depends on the occurrence of vacancies, there is no guarantee that all candidates included in the list will secure appointment. The candidates remaining in the list at the time of cancellation will have no claim at all for appointment on the basis of the inclusion of their names in the list.

According to the existing procedure, re-valuvation of Answer Script is not allowed. But rechecking of marks will be done on payment of **Rs.80/-.** The fee should be remitted in any one of the treasuries in the State under the head of account "0051 PSC – 105 State PSC – 99 Examination Fee" and original chalan enclosed with the application. Applications for rechecking of answer scripts should be submitted in the prescribed form available free of cost from the enquiry sections of the various offices of the Commission or its photocopy or downloaded and printed in A4 size paper from the Commission's website <a href="www.keralapsc.gov.in">www.keralapsc.gov.in</a> or photocopied therefrom. Applications submitted in any other manner will not be considered. The original chalan receipt together with the application for rechecking should reach the **District Officer, KPSC District Office, Alappuzh**a within **45 days** from the date on which this Ranked List is brought into force. The fee once remitted will not be refunded on any account.

Candidates who wish to obtain a photocopy of their OMR answer script (Part A & Part B) relating to this selection shall remit a fee of **Rs.315**/- by way of chalan in any of the treasuries in the State (Head of Account **0051 PSC - 800 State PSC - other receipts**) The duly filled up application in the prescribed form (available from the Commission's website) along with the original chalan should be submitted to the **District Officer, KPSC District Office, Alappuzha** within **45 days** from the date on which the Ranked List is brought into force. A copy of the answer sheet will be issued only once to a candidate. Candidates are prohibited from applying for copy of answer sheet which is not their own, and legal proceedings will be initated against those who do so.

"Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazette Officer of State/Central Government with signature, Name, Designation and Office seal along with a notarized affidavit and a self attested copy of an ID proof bearing photograph as enlisted in the General Conditions. The request for relinquishment received within 15 days from the date of publication of Ranked List in the official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission upto the finalization of Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised."

Valid applications for recehecking/photocopy of answer script addressed to **District Officer, KPSC District Office, Alappuzha** shall reach this office within 45 days from the date on which the Ranked List is brought into force. The last date for receipt of applications for rechecking/photocopy of answer script is **18.01.2019.** Application for rechecking/photocopy received after the prescribed time limit and not in the prescribed form will not be entertained.
