NOTIFICATION

The following list contains the names of candidates who are found suitable on the basis of the result of the Objective Type (OMR Valuation) Test held on 07/01/2017 for selection to the post of **Laboratory Assistant (SR from SC/ST and ST only)** (Category No. **099/2016**) on ₹ **8960** - **14260**/-in **Kerala Higher Secondary Education Department** in Kasaragod District arranged in the order of merit. The Ranked List is brought into force with effect from **19.12.2018**.

The list of selected candidtes published by the Commission shall remain in force for a minimum period of one year and a maximum period of three years provided that the said list will not continue to be in force if a new list after the expiry of the minimum period of one year is published. Recruitment will be made for the reported vacancies and also for the vacancies reported for Special Recruitment from Scheduled Castes/Scheduled Tribes during the pendency of the list. Candidates against vacancies reported exclusively for Scheduled Tribes will also be advised from this list and only in the absence of Scheduled Tribe candidates in this list fresh notification for vacancies reserved exclusively for Scheduled Tribes will be issued.

Since a common OMR test with common candidates was conducted for this post, the marks awarded to the candidates included in the Ranked List and marks of OMR test relating to all candidates appeared for the test will be published only after the publication of entire Ranked Lists which will be finalised on the basis of the common test.

According to the existing procedure, re-valuation of answer scripts is not allowed. But answer scripts will be rechecked if prescribed fee of ₹ 80/- (Rupees Eighty only) is remitted in any one of the Treasuries in the State by chalan under the Head of Account "0051 PSC 105 State PSC 99 Examination Fee". Applications for rechecking of answer scripts should be submitted in the prescribed form available free of cost from the enquiry sections of the various offices of the Commission or its photocopy or downloaded and printed in A4 size paper from the Commission's website www. keralapsc.gov.in in or photocopied there from. The original Chalan receipt for the prescribed fee should be produced with the application for rechecking. Applications submitted in any other manner will not be considered. The result of re-checking of OMR answer scripts will be intimated in due course.

Candidates who wish to obtain a photocopy of their OMR answer sheet (Part A & Part B) relating to this selection shall remit a fee of ₹ 315/- (Rupees Three hundred and Fifteen only) by way of chalan in any of the Treasuries in the State under the Head of Account 0051-PSC-800- State PSC -99 Other receipts. The duly filled up application in the prescribed form (available from the Commission's Website www. keralapsc.gov.in) along with the original chalan should be submitted to the District Officer, KPSC District Office, Kasaragod within 45 days from the date on which the Ranked List has come in to force. But photocopy of the OMR answer script will be issued only after the publication of the Ranked List for all the posts finalised on the basis of the common test. A copy of the answer sheet will be issued only once to a candidate. Candidates are prohibited from applying for a copy of answer sheet which is not their own, and legal proceedings will be initiated against those who do so.

Valid applications for rechecking/obtaining photocopy of Answer Scripts along with original chalan receipt addressed to the District Officer, Kerala Public Service Commission, District Office, Kasaragod shall reach this office within 45 days from the date on which the Ranked List has come in to force (ie., The date on which the Ranked List has been approved by the Commission). The last date for receipt of application for rechecking/obtaining photocopy of the Answer Script is **01.02.2019**. Applications for rechecking /obtaining photocopy received after the prescribed time limit or not in the prescribed form will not be entertained. The fee once remitted will not be refunded on any account. In the case of candidates who send application for rechecking in the prescribed form within the prescribed time limit enclosing original chalan receipt as stated above, the marks awarded will be rechecked and the result of the rechecking will be intimated to the candidates from this office.

"Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/ Central Government with Signature, Name, Designation and Office Seal along with a notarized affidavit and a self attested copy of an ID proof bearing photograph as enlisted in the General Conditions". The request for relinquishment received within 15 days from the date of publication of Ranked List in the official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission upto the finalisation of Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised.
