### **NOTIFICATION**

The following list contains the names of candidates found suitable on the basis of the result of the Objective Type Test (OMR Valuation) held on **18.02.2017, Physical Measurement** and the verification of original documents of candidates included in the Short List published on **20.08.2018** for selection to the post of **RESERVE WATCHER/DEPO WATCHER on Rs.16500 - 35700 in FOREST DEPARTMENT Thrissur District** (Category No: **354/2016**, Gazette Date: **11.11.2016**) arranged in the order of merit. The Ranked List is brought into force with effect from **21.12.2018**. The Ranked List will be in force till the publication of a new Ranked List after the expiry of a minimum period of one year or till the expiry of three years whichever is earlier. Candidates from this list will be advised for appointment in accordance with the rules and orders regarding reservation and rotation as amended from time to time, if applicable, against vacancies reported to the commission during the pendency of the list. As the advice for appointment depends on the occurrence of vacancies, there is no guarantee that all candidates included in the list will secure appointment. In case, no candidate is advised from the ranked list till the expiry of the period of three years, the duration of the ranked list shall be extended for a further period of one year or till at least one candidate is advised from the the list whichever is earlier. The candidates remaining in the list at the time of cancellation will have no claim at all for appointment on the basis of the inclusion of their names in the list.

*“Being a common test, the marks secured by the candidates in the OMR Test are not published in the Ranked List.”*

According to the existing procedure, revaluation of answer script is not allowed. But rechecking of marks will be done on payment of Rs.80/- (Rupees Eighty only). The fees should be remitted in any one of the Treasuries in the State by chalan under the Head of Account **“0051 PSC 105 STATE PSC-99 EXAMINATION FEE”** and original chalan enclosed with the application. Applications for re-checking of answer scripts should be submitted in the prescribed form available free of cost from the Enquiry Section of the various offices of the Commission or its photocopy or downloaded and printed in A4 size paper from the Commission’s website: [www.keralapsc.gov.in](http://www.keralapsc.gov.in) or photocopied there from. Applications submitted in any other manner will not be considered. The original chalan receipt together with the application for rechecking should reach **District Officer, KPSC District Office, Thrissur**, within 45 days from the date on which this Ranked List is brought into force. The fee once remitted will not be refunded on any account.

Candidates who wish to obtain a Photocopy of their OMR answer sheet (Part A and Part B) relating to this selection shall remit the fees of Rs.315/- (Rupees Three Hundred and fifteen only) by way of chalan in any one of the Treasuries in the State by chalan under the Head of Account **“0051-PSC-800 STATE PSC - 99 OTHER RECEIPTS”**. The duly filled up applications in the prescribed form (available from the Commission's website) along with the original chalan should be submitted to the District Officer, KPSC District Office, Thrissur within 45 days from the date on which the Ranked List is brought into force. A copy of the answer sheet will be issued only once to a candidate. Candidates are prohibited from applying for copy of answer sheet which is not their own and legal proceedings will be initiated against those who do so.

*“Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/Central Government with signature, Name, Designation and Office Seal along with an affidavit from NOTARY PUBLIC and self attested copy of I.D. proof bearing photograph as*

*enlisted in the General Conditions. The request for relinquishment received **within 15 days** from the date of publication of the Ranked List in the official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission upto the finalisation of the Ranked List. After the publication of the Ranked List, the request for the relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised."*

*Entries put in column 8 (community) are based on the communities specified by the candidates in their applications and proved by them with necessary documents. The candidates whose communities have not been correctly noted in the list as proved by them in their applications should intimate the fact to the District Officer, KPSC District Office, Thrissur within one month from the date of publication of the Ranked List, to get the benefit of reservation to which they are entitled to. In the absence of timely information regarding discrepancies, if any, the candidates will be advised on the basis of communities specified in the list.*

Valid applications for re-checking/obtaining photocopy of answer script addressed to the District Officer, Kerala Public Service Commission District Office, Thrissur shall reach this office within 45 days from the date on which the Ranked List has come into force (i.e. the date on which the Ranked List has been approved by the commission). The last date for receipt of applications for rechecking/ obtaining photocopy of the answer script is **04.02.2019**. Applications for rechecking/obtaining photocopy, received after the prescribed time limit and not in the prescribed form will not be entertained.
