NOTIFICATION

The following is the Ranked list of candidates for the post of LOWER DIVISION CLERK (TAMIL AND MALAYALAM KNOWING) (NCA -MUSLIM) (**Category No. 031/2015** in various Department in the order of the merit based on the marks secured in the Descriptive Type Test held on 13.06.2017. The Ranked List is brought into force with effect from **16.08.2018**.

The Ranked List will remain in force until candidates are advised and appointed against the NCA vacancies notified for MUSLIM community remain unfilled due to paucity of the candidates during the currency of Ranked List published for the post on 04.12.2012 in Palakkad District as category No. 305/07. As advice for appointment depends on the occurrence of vacancies, there is no guarantee that all candidates included in the list will secure appointment. The candidates remaining in the list at the time of cancellation will have no claim at all for appointment on the basis of the inclusion of their names in the list.

According to the existing procedure, re-valuation of Answer Script is not allowed. But Answer Script will be re-checked to see that all the answers are valued and that there is no mistake in the totaling of marks for various answers if the the candidates apply for rechecking, remitting prescribed fee of Rs. 75/- (Rupees Seventy Five) in any one of the treasuries in the State under the head of account "0051 PSC - 105 State PSC- 99 Applications for rechecking of answer scripts should be submitted in **Examination Fee**". the prescribed form available free of cost from the enquiry sections of the various offices of the Commission or its photocopy or downloaded and printed in A4 size paper from the Commission's website www.keralapsc.gov.in or photocopied therefrom. Applications submitted in any other manner will not be considered. The application for re-checking along with the original chalan receipt should reach the District Officer, K.P.S.C District Office, Palakkad within 45 days from the date on which the Ranked List has come into force. Application for re-checking received after the prescribed time limit or not in the prescribed form will not be entertained. The fee once remitted will not be refunded on any account. In the case of candidates who sent application for re-checking in the prescribed form within the time limit enclosing original chalan receipt as stated above, the marks awarded will be re-checked and the result of the re-checking will be intimated to the candidates from this office. Applications for re-checking received from candidates whose answer script have been invalidated will not be considered.

Candidates who wish to obtain a photocopy of their OMR answer sheet (Part A & Part B) relating to this selection shall remit a fee of **Rs.300/- (Rupees Three hundred only)** by way of chalan in any of the treasuries in the State under the Head of Account "**0051 PSC-800 State PSC – 99 other receipts'**. The duly filled up application in the prescribed form (available in the commission's website www.keralapsc.gov.in) along with the original chalan should be submitted to **the District Officer, K.P.S.C District Office, Palakkad** within 45 days from the date on which the Ranked List has come into force. A copy of the answer sheet will be issued only once to a candidate. Candidates are prohibited from applying for copy of answer sheet which is not their own, and legal proceedings will be initiated against those who do so.

The last date for the receipt of applications for re-checking/ obtaining Photocopy of the OMR answer scripts is 29.09.2018. Application for re-checking / obtaining Photocopy received after the prescribed time limit and not in the prescribed form will not be entertained.

Entries put in column 8 (Community) are based on the communities specified by the candidates in their profile and proved by them with necessary documents. The candidates whose communities have not been correctly noted in the Ranked list as proved by them in their applications (profile) should intimate the fact to the **District Officer, Kerala Public Service Commission District Office, Palakkad** within one month from the date of publication of the Ranked list, to get the benefit of reservation to which they are entitled to. In the absence of timely information regarding discrepancies, if any, the candidates will be advised as incorporated in the list.

"Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/Central Government with signature, name, designation and Office Seal along with a notarized affidavit and a self attested copy of an ID proof bearing photograph as enlisted in the General conditions. The request for relinquishment received within 15 days from the date of publication of Ranked List in the the official website of Kerala Public Service Commission will be honoured against the requisitions of vacancies that are pending with the Commission upto the finalization of ranked list. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised."
