Note:- (4) Candidates included in the short List should present and produce in person the original documents for One Time Verification. Date, Time and Venue of practical test of candidates included in this short list will be intimated in due course.

Note :- (5) Candidates belonging to SC/ST Communities shall produce Community Certificate issued by the Revenue Authority and candidates belonging to Other Backward Classes who are required to produce Non - Creamy Layer Certificate as per G.O (P) No: 81/09/SC/ST/DD dated 26.09.2009 shall produce the same along with the other documents mentioned above at the time of verification of original documents.

Note:- (6) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (7) Copy of answer scripts of the OMR Test held on **21/10/2017** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No : **ER IX(1)695/2018/EW dated.21.01.2019.**
