SC/ST candidates included in the short list are required to produce Community Certificate issued under rule 4 of Kerala(scheduled caste and Scheduled Tribes) Regulation of issue of Community Certificate rules,2002 by the Revenue Authority.

Note :- (6) Copy of answer scripts of the OMR Test held on **27/11/2015** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
