Note (1) :- Candidates who wish to obtain a photocopy of their OMR answersheet (Part A & Part B) relating to this selection shall remit a fee of Rs.315/- in any of the Treasuries in the State under the head of account "0051 PSC-800-StatePSC-99 other receipts". The duly filled in application in the prescribed form (available from the Commission's website [www.keralapsc.gov.in](http://www.keralapsc.gov.in)) along with the original chelan should be submitted to DEPUTY SECRETARY (EXAMINATIONS)-II, KERALA PUBLIC SERVICE COMMISSION, PATTOM. P.O., THIRUVANANTHAPURAM - 695004 within 45 days from the date on which this ranked list is brought into force. A copy of an answerscript will be issued only once to a candidate. Copies of OMR answer sheets invalidated due to any defect will not be issued. Candidates are prohibited from applying for copy of an answer sheet which is not their own, and legal proceedings will be initiated against those who do so.

Note (2) :- According to the existing procedure, revaluation of Answer Script is not allowed. But Answer Scripts will be rechecked if the candidates apply for in the prescribed application form available free of cost from the Enquiry Sections of the various Offices of the Commission or its photocopy, or downloaded and printed in A4 size paper from the Commission's website [www.keralapsc.gov.in](http://www.keralapsc.gov.in) or Photocopied there from along with prescribed fee of **Rs. 80/- (Rupees Eighty Only)** under the Head of Account "**0051 - PSC - 105 State PSC 99 - Examination Fee**" addressed to the **Deputy Secretary (Examinations)-II, Kerala Public Service Commission, Pattom P.O., Thiruvananthapuram. - 4.** Applications submitted in any other manner will not be considered. A period of 45 (Forty Five) days time to apply for rechecking of Answer Scripts will be allowed to candidates with effect from the Date of Approval of the Ranked List. Candidates can avail only one chance after the approval of Ranked List. Rechecking of invalidated answer scripts due to any defects will not be considered. Application for Rechecking received after the stipulated time will not be entertained and Fee once remitted will not be refunded.

Note (3):- "Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of the State/Central Government with signature, name, designation and office seal along with a notarized affidavit and a self attested copy of an ID proof bearing photograph as enlisted in the General conditions. The request for relinquishment received within 15 days from the date of publication of Ranked List in the official website of the commission will be honoured against the requisitions of vacancies that are pending with the Commission upto the finalisation of ranked list. After the publication of ranked list, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition based on which he/she is to be advised".

Note (4):- "The A part and B part of OMR scripts will be destroyed after completing six months period from the date of finalisation of Ranked List.
