NOTIFICATION

The following is the list of candidates found suitable by the Commission on the basis of Objective Type (OMR valuation) Test held on 02.08 .2017 for selection to the post of Junior Public Health Nurse Gr II(NCA-Viswakarma) (**Category No. 026/2017**) on Rs.22200-48000 in Health Services/Municipal Common Service **Department** in Malappuram District arranged in the order of merit.

Since a Common Test/OMR Test with common candidates was conducted for the post, the marks awarded to the candidates included in this Ranked List and marks of OMR Test relating to all candidates appeared for the test will be published only after the publication of entire Ranked Lists (including NCA notifications) which will be finalised on the basis of the common test.

This NCA Ranked List is brought in to force w.e.f 25/01/2019 and will be valid until the candidates are advised and appointed against the vacancies notified due to paucity of candidates belonging to Viswakarma community during the currency of the mother ranked list published on 17/08/2016 or three years from the date of publication of this NCA Ranked List whichever is earlier.

As the advice for appointment depends on the occurrence of vacancies, there is no guarantee that all candidates included in the list will secure appointment. The candidates remaining in the list at the time of cancellation will have no claim at all for appointment on the basis of the inclusion of their names in the list.

According to the existing procedure, revaluation of answer script is not allowed. But rechecking of marks will be done on payment of **Rs.80/-** (Rupees Eighty only). The fee should be remitted in any one of the Treasuries in the State under the Head of Account **“0051- PSC- 105 STATE PSC - 99 EXAMINATION FEE”** and original Chalan should be enclosed with the application. Application for rechecking of answer scripts should be submitted in the prescribed form available free of cost from the Enquiry Section of the various offices of the Commission or its photocopy or downloaded and printed in A4 size paper from the Commission’s website/ **www.keralapsc.gov.in** or photocopied there from. Applications submitted in any other manner will not be considered. The original Chalan receipt together with the application for rechecking should

reach the District Officer, K.P.S.C District Office, Malappuram within 45 days from the date on which this Ranked List is brought into force. The fee once remitted will not be refunded on any account.

Candidates who wish to obtain a photocopy of their OMR answer sheet (Part A & Part B) relating to this selection shall remit the fee of **Rs.315/-** (Rs. Three Hundred and Fifteen only) by way of chalan in any of the Treasuries in the State. **Head of Account 0051 -PSC- 800-State PSC- 99 Other receipts**). The duly filled up application in the prescribed form (available from the Commission's Website www.keralapsc.gov.in) along with the original Chalan should be submitted to the District Officer, KPSC District Office, Malappuram within 45 days from the date on which the Ranked List is brought into force. A copy of the answer sheet will be issued only once to a candidate. Copies of OMR Sheet invalidated due to any defect will not be issued. Candidates are prohibited from applying for copy of answer sheet which is not their own, and legal proceedings will be initiated against those who do so.

“Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/Central Government with signature, name, designation and Office Seal along with a notarized affidavit and a self attested copy of an ID proof bearing photograph as enlisted in the General Conditions”. The request for relinquishment received within 15 days from the date of publication of the Ranked List in the official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission up to the finalisation of Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised.

Valid applications for rechecking/ obtaining photocopy of answer script addressed to District Officer, K.P.S.C District Office, Malappuram shall reach this office within 45 days from the date on which the Ranked List is brought into force.(ie; the date on which the Ranked List has been approved by the Commission). The last date for receipt of applications for rechecking/ obtaining photocopy of answer script is **10/03/2019**. Application for rechecking/obtaining photocopy received after the prescribed time limit and not in the prescribed form will not be entertained.
