Note :- (5) Candidates belonging to Other Backward Classes included in this list who are required to produce Non - Creamy Layer Certificate as per G.O (P) No: 81/09/SC/ST/DD dated 26.09.2009 shall produce the same along with the other documents to prove age, qualification etc at the time of verification of original documents. SC/ST candidates shall produce community certificate in Form No.III issued under rule 4 of the Kerala (SC&ST) regulations of issue of community certificate rules 2002 or Online Community Certificate with digital signature issued by the Competent Authority.

Note :- (6) Copy of answer scripts of the OMR Test held on **04/04/2018** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
