Applications submitted in any other manner will not be considered. A period of 45 (Forty Five) days time to apply for rechecking of Answer Scripts will be allowed to candidates with effect from the Date of Approval of the Ranked List. Rechecking of invalidated answer scripts due to any defects will not be considered. Application for Rechecking received after the stipulated time will not be entertained and Fee once remitted will not be refunded.

NOTE (2) :- Candidates who wish to obtain a photocopy of their OMR Answer Sheets (Part A & Part B) relating to this selection shall remit a Fee of Rs. 335/- (Rupees Three Hundred and thirty five only) in any of the Treasuries in the State (Head of Account : 0051 - PSC - 800 - State PSC -99-Other Receipts). The duly filled in application in the prescribed form available from the website of the Commission www.keralapsc.gov.in along with the original chalan should be submitted to the Deputy Secretary II (Examinations) Kerala Public Service Commission, Pattom P.O., Thiruvananthapuram- 695004 within 45 (Forty Five) days from the date of approval of the Ranked List. A copy of an answer sheet will be issued only once to a candidate.Copies of OMR answer sheets invalidated due to any defect will not be issued. Candidates are prohibited from applying for copy of an answer sheet which is not their own, and legal proceedings will be initiated against those who do so. The last date for receipt of applications is 04/12/2019.Applications received after the prescribed date will not be entertained.
