## **NOTIFICATION**

The following list contains the name of candidates found suitable on the basis of the result of the Objective Type (OMR valuation) Test held on 18.02.2017 and verification of original documents of the candidates included in the Short Lists, published on 14.08.2018 for selection to the post of Reserve Watcher/ Depot Watcher/ Survey Lascars/TB Watchers/ Bunglow Watchers/Depot and Watch Station Watcher/Plantation Watchers / Maistries / Timber Supervisors/ Tope Warden/ Thana Watcher/ Dispensary Attendant (Category No. 354/2016) on Rs.16500-35700/- in **Forest Department in Pathanamthitta District** notified in the Gazette dated 11.11.2016 arranged in the order of merit. A common objective type (OMR valuation) test was held on 18.02.2017. Hence marks secured by the candidates included in the Ranked List are hidden.

The Ranked List is brought into force with effect from **21.12.2018.** The Ranked list will be inforce till the publication of a new Ranked List after the expiry of a minimum period of one year or till the expiry of 3 years whichever is earlier. Candidates from the list will be advised for appointment in accordance with the rules and orders regarding reservation and rotation as amended from time to time, if applicable, against vacancies reported to the Commission during the pendency of the list. As the advice for appointment depends on the occurrence of vacancies, there is no guarantee that all candidates included in the list will secure appointment. The candidates remaining in the list at the time of cancellation will have no claim at all, for appointments on the basis of the inclusion of their names in the list.

According to the existing procedure, revaluation of answer script is not allowed. But answer scripts will be rechecked, to see that all the answers are valued and that there is no mistake in the totalling of marks for various answers if the candidates apply for rechecking, remitting the prescribed fee of **Rs.80**/- (Rupees Eighty only) in any one of the Treasuries in the State by chalan under the Head of Account "0051 PSC 105 State PSC 99 Examination Fee".

Applications for rechecking of answer scripts should be submitted in the prescribed form available free of cost from the enquiry sections of the various offices of the Kerala Public Service Commission or its photocopy or downloaded and printed in A4 size paper from the Commission's Website <a href="www.keralapsc.gov.in">www.keralapsc.gov.in</a> or photocopied there from. Applications submitted in any other manner will not be considered. The applications for rechecking of answer script along with the original chalan receipt should reach the District Officer, Kerala Public Service Commission District Office Pathanamthitta within 45 days from the date on which this Ranked List has come into force (i.e. the date on which the Ranked List has been approved by the Commission.) Application for rechecking received after the prescribed time

limit or not in the prescribed form will not be entertained. The fee once remitted will not be refunded on any account. In the case of candidates who sent applications for rechecking in the

prescribed form within the prescribed time limit enclosiong original chalan receipt as stated above. The marks awarded will be rechecked and the result of the rechecking will be intimated to the candidates from this office. Application for rechecking received from the candidates whose answer scripts have been invalidated will not be considered.

Candidates who wish to obtain a photocopy of their OMR answer sheet (Part A&B) relating to this selection shall remit the fees of Rs.315/- (Rupees Three hundred and Fifteen only) in any one of the Treasuries in the State by chalan under the Head of Account <u>0051-PSC-800-State PSC-99 Other receipts.</u> The duly filled up applications in the presribed from (available from the Commision's <u>website www.keralapsc.gov.in</u>) along with the original chalan should be submitted to the District Officer, KPSC District Office Pathanamthitta within 45 (forty five) days from the date on which this Ranked List has come into force (i.e. the date on which the Ranked List has been approved by the Commission.) A copy of the answer sheet will be issued only once to a candidate. Copies of OMR sheet invalidated due to any defect will not be issued. Candidates are prohibited from applying for a copy of answer sheet which is not their own, and legal proceedings will be initiated against those who do so.

The last date for receipt of application for rechecking / obtaining photo copy of answer scripts is **03.02.2019**. Application for rechecking / obtaining photo copy received after the prescribed time limit or not in the prescribed form will not be entertained.

Entries put in column 8 (Community) are based on the communities specified by the candidates in their application forms and proved by them with necessary documents. The candidates whose communities have not been correctly noted in the list as proved by them in their applications should intimate the fact to the District Officer, Kerala Public Service Commission District Office, Pathanamthitta within 1 (one) month from the date of publication of the Ranked list to get the benefit of reservation to which they are entitled to. In the absence of timely information regarding discrepancies, if any, the candidates will be advised as incorporated in this list.

"Any candidate can relinquish his right for appointment in writing duly attested by a Gazetted Officer of State/Central Government with signature, name, designation and Office seal along with a notarized affidavit and self attested copy of an ID proof bearing photograph as enlisterd in the general conditions. The request for relinquishment received within 15 days from the date of publication of Ranked List in the officical web site of the commission will be honoured against the requisitions of vacancies that are pending with the Commission upto the finalisation of Ranked List. After the publication of the Ranked List, the request of
