Note :- (6) Candidates belonging to Other Backward Classes included in this list who are required to produce Non - Creamy Layer Certificate as per G.O (P) No: 81/09/SC/ST/DD dated 26.09.2009 or GO(MS) 5/2014/BCDD dated 31.01.2014 shall produce the same along with the other documents mentioned above at the time of verification of original documents. SC/ST candidates included in this list are required to produce community certificate issued under Rule 4 of the Kerala (Scheduled Cast and Scheduled Tribes) regulation of issue of community certificate Rules 2002 by the revenue authorities.

Note :- (7) Copy of answer scripts of the OMR Test held on **04/11/2017** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
