## **NOTIFICATION**

The following list contains the names of candidates who are found suitable on the basis of the result of the **Objective Type (OMR Valuation) Test** held on **26.07.2018** and the verification of original documents that followed for selection to the post of **LOWER DIVISION TYPIST** (1st NCA-LC/AI) (Category No. 216/2017) on Rs.19,000-43,600/- in Various Department in Palakkad District arranged in the order of merit. A Common Objective Type (OMR Valuation) Test was held on 26.07.2018. Hence marks secured by candidates included in the Ranked List are hidden.

The Ranked List is brought into force with effect from **16.08.2019**. The Ranked List will remain in force until candidates are advised and appointed against the NCA vacancies notified for Latin Catholics/Anglo Indian Community but remain unfilled due to the paucity of candidates during the currency of the Ranked List published for the post on 17.05.2012 in Palakkad District as Category No. 205/2009 for the above post. As the advise for appointment depends on the occurrence of vacancies, there is no guarantee that all candidates included in this list will secure appointment. The candidates remaining in the list at the time of cancellation will have no claim at all for appointment on the basis of the inclusion of their names in the list.

According to the existing procedure, re-valuation of answer scripts is not allowed. But answer scripts will be rechecked if prescribed fee of **Rs. 85/- (Rupees Eighty Five Only)** is remitted in any one of the Treasuries in the State by chalan under the Head of Account ''0051-PSC-105 State PSC-99 **Examination Fee'**. Applications for rechecking of answer scripts should be submitted in the prescribed form available free of cost from the enquiry sections of the various offices of the Commission or its photocopy or downloaded and printed in A4 size paper from the Commission's

website <u>www.keralapsc.gov.in</u> or photocopied there from. The original Chalan receipt for the prescribed fee should be produced with the application for re-checking. Applications submitted in any other manner will not be considered.

Candidates who wish to obtain a photocopy of their OMR answer sheet (Part A & Part B) relating to this selection shall remit a fee of **Rs. 335/- (Rupees Three Hundred and Thirty Five Only)** by way of chalan in any of the Treasuries in the State under the Head of Account ''0051-PSC-800-State PSC-99'' other receipts. The duly filled up application in the prescribed form (available from the Commission's website <a href="www.keralapsc.gov.in">www.keralapsc.gov.in</a>) along with the original chalan should be submitted to The District Officer, Kerala Public Service Commission District Office, Palakkad within 45 days from the date on which the Ranked List is brought into force. A copy of an answer sheet will be issued only once to a candidate. Candidates are prohibited from applying for a copy of an answer sheet which is not their own, and legal proceedings will be initiated against those who do so.

Valid applications for rechecking / obtaining photocopy of Answer Scripts along with original chalan receipt addressed to the District Officer, Kerala Public Service Commission, District Office, Palakkad shall reach this office within 45 days from the date on which the Ranked List has come into force (ie.,The date on which the Ranked List has been approved by the Commission). The last date for receipt of application for rechecking/obtaining photocopy of the Answer Script is **30.09.2019**. Applications for rechecking/obtaining photocopy received after the prescribed time limit or not in the prescribed form or not with the original chalan receipt for prescribed fee will not be entertained. The fee once remitted will not be refunded on any account. In the case of candidates who send application for rechecking in the prescribed form within the prescribed time limit enclosing original chalan receipt as stated above, the marks awarded will be rechecked and the result of the rechecking will be intimated to the candidates from this office.

Entries put in column 8 (community) are based on the communities specified by the candidates in their application forms and proved by them with necessary documents. The candidates whose communities have not been correctly noted in the list as proved by them in their applications should intimate the fact to the District Officer, Kerala Public Service Commission District Office, Palakkad within 1 (One) month from the date of publication of the Ranked List to get the benefit of reservation

which they are entitled to. In the absence of timely information regarding discrepancies, the candidates will be advised as incorporated in this list.

"Any candidates can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State / Central Government with Signature, Name, Designation and Office Seal along with a notarized affidavit and a self attested copy of an ID Proof bearing photograph as enlisted in the General Conditions". The request for relinquishment received within 15 days from the date of publication of Ranked List in the official website of the Commission will be honoured against requisitions of vacancies that are pending with the Commission upto the finalisation of Ranked List. After the publication of the Ranked list, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised.
