**NOTIFICATION**

The following is the Ranked list of candidates for the post of **Driver on Rs 19000-43600/- in Excise Department (Category No. 659/2017) in Kozhikode District** notified in the Gazette dated 30.12.2017 and found suitable by the Commission and arranged in the order of merit based on the marks secured in the OMR Test held on **04.04.2018** and Practical Test held from **11.06.2019 to 13.06.2019**. The Ranked List is brought into force with effect from **04-09-2019**.

The Ranked List will remain in force till the publication of a new Ranked List after the expiry of a minimum period of one year or till the expiry of three years whichever is earlier. Candidates from this list will be advised for appointment in accordance with the rules and orders regarding reservation and rotation as amended from time to time, if applicable, against vacancies reported to the Commission during the pendency of the list. As the advice for appointment depends on the occurrence of vacancies, there is no guarantee that all candidates included in the list will secure appointment. The candidates remaining in the list at the time of cancellation will have no claim at all for appointment on the basis of the inclusion of their names in the list.

According to the existing procedure, re-valuation of Answer Script is not allowed. But re-checking of marks will be done on payment of Rs. **85/-**(Rupees Eighty five only). The fee should be remitted in any one of the treasuries in the State under the head of account "**0051 PSC - 105 State PSC- 99 Examination Fee**" and original chalan enclosed with the application. Applications for rechecking of answer scripts should be submitted in the prescribed form available free of cost from the enquiry sections of the various offices of the Commission or its photocopy or downloaded and printed in A4 size paper from the Commission's website/ [www.keralapsc.gov.in](http://www.keralapsc.gov.in)/or photocopied there from. Applications submitted in any other manner will not be considered. The original chalan receipt together with the application for re-checking should reach **the District Officer, K.P.S.C District Office, Civil Station, Kozhikode** within 45 days from the date on which this Ranked List is brought into force. The fee once remitted will not be refunded on any account. In the case of candidates who sent applications for rechecking in prescribed form within the prescribed time limit enclosing original chalan receipt as stated above, the marks awarded will be rechecked and the result of the rechecking will be intimated to the candidates from this office. Applications for rechecking received from the candidates whose answer scripts have been invalidated will not be considered.

Candidates who wish to obtain a photocopy of their OMR answer sheet (Part A & Part B) relating to this selection shall remit a fee of Rs. 335/- (Rupees Three hundred and thirty five only) by way of chalan in any of the treasuries in the State (Head of Account **0051 PSC-800 State PSC – 99 other receipts**). The duly filled up application in the prescribed form (available from the commission's website) along with the original challan should be submitted to the **District Officer, K.P.S.C District Office, Civil Station, Kozhikode** within 45 days from the date on which the Ranked List is brought into force. A copy of the answer sheet will be issued only once to a candidate. Candidates are prohibited from applying for copy of answer sheet which is not their own, and legal proceedings will be initiated against those who do so.

Valid applications for rechecking/ photocopy of answer script addressed to **District Officer, K.P.S.C District Office, Civil Station, Kozhikode** shall reach this office within 45 days from the date on which the Ranked List is brought into force. **The last date for receipt of applications for rechecking/ photocopy of answer script is 18.10.2019.** Application for rechecking/ photocopy received after the prescribed time limit and not in the prescribed form will not be entertained. Photo copy of the OMR answer script will be issued only after the publication of the Ranked List for all the posts finalised on the basis of the common test.

The entries put in column 8 are based on the communities specified by the candidates in their application forms and proved by them with necessary documents. The candidates whose communities have not been correctly noted in the list as proved by them should intimate the fact to the District Officer, Kerala Public Service Commission District Office, Civil Station, Kozhikode within one month from the date of publication of the list to get the benefit of reservation to which they are entitled to. In the absence of timely information regarding discrepancies, if any, the candidates will be advised as incorporated in the list.

Since a common OMR test with common candidates were conducted for this post, the marks awarded to the candidates included in the ranked list and marks of OMR test relating to all candidates appeared for the test will be published only after the publication of entire ranked lists (including NCA notification) which will be finalised on the basis of the common test.

***“Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/Central Government with signature, name, designation and Office Seal along with a notarized affidavit and a self attested copy of an ID proof bearing photograph as enlisted in the General Conditions. The request for relinquishment received within 15 days from the date of publication of Ranked List will be honoured against the requisitions of vacancies that are pending with the Commission upto the finalization of ranked list. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised.”***
