## **NOTIFICATION**

The following is the list of candidates found suitable by the Commission on the basis of the Objective Type (OMR Valuation) Test held on 20.01.2018 and the verification of original documents of candidates included in the Probability List published on 04.07.19 for selection to the post of Female Warden on Rs. 9190-15780 in SC Development Department in Malappuram District (Category No. 093/2015) notified in the Gazette dated 29.04.15 and arranged in the order of merit. The Ranked List is brought into force with effect from **20.09.2019.** 

The Ranked List will remain in force till the publication of a new Ranked List after the expiry of a minimum period of one year or till the expiry of three years whichever is earlier. Candidates from this list will be advised for appointment in accordance with the rules and orders regarding reservation and rotation as amended from time to time, if applicable, against vacancies reported to the Commission during the pendency of the list. As the advice for appointment depends on the occurrence of vacancies, there is no guarantee that all the candidates included in this list will secure appointment. The candidates remaining in the list at the time of cancellation will have no claim at all for appointment on the basis of the inclusion of their names in the list.

The entries put in column **8** are based on the communities specified by the candidates in their applications and proved by them with necessary documents. The candidates whose communities have not been correctly noted in the list as proved by them should intimate the fact to the District Officer, Kerala Public Service Commission District Office, Malappuram

within one month from the date of publication of the list to get the benefit of reservation to which they are entitled to. In the absence of timely information regarding discrepancies, if any, the candidates will be advised as incorporated in this list.

According to the existing procedure, revaluation of answer script is not allowed. But rechecking of marks will be done on payment of **Rs. 85** (**Rupees Eighty Five only**). The fee should be remitted in any one of the Treasuries in the State by chalan under the Head of Account " **0051- PSC- 105- State PSC- 99 Examination Fee**" and original chalan should be enclosed with application. Application for re-checking of answer scripts should be submitted in the prescribed format available free of cost from the Enquiry Section of the various offices of the Kerala Public Service Commission or its photocopy or downloaded and printed in A4 size paper from the Commission's website: **www.keralapsc.gov.in** or photocopied there from. Applications submitted in any other manner will not be considered. The original chalan receipt together with application for rechecking should reach the **District Officer, KPSC District Office, Malappuram** within 45 days from the date on which this Ranked List brought into force. The fee once remitted will not be refunded on any account.

Candidates who wish to obtain a Photocopy of their OMR answer sheet (Part A and Part B) relating to this selection shall remit the fees of Rs.335/- (Rupees Three Hundred and thirty five only) in any one of the Treasuries in the State by chalan under the Head of Account "0051-PSC-800-State PSC-99 OTHER RECEIPTS. The duly filled up application in the prescribed form (Available from the Commission's Website) along with the original chalan should be submitted to the District Officer, KPSC District Office Malappuram within 45 days from the date on which the Ranked List brought into force. A copy of the answer sheet will be issued only once to a candidate. Candidates are prohibited from applying for copy of answer sheet which is not their own and legal proceedings will be initiated against those who do so.

Valid applications for re-checking/obtaining photocopy of answer script addressed to the **District Officer, Kerala Public Service Commission District Office, Malappuram** shall reach this office within **45 days** from the date on which the Ranked List has come into force (ie. the date on which the Ranked List has been approved by the commission). The last date for receipt of applications for re-checking/obtaining photocopy of the answer script is **03/11/2019.** Applications for re-checking/obtaining photocopy, received after the prescribed time

limit and not in the prescribed form will not be entertained.

Since a common OMR Test with common candidates was conducted for the post, the

marks awarded to the candidates appeared for the test will be published only after the

publication of entire ranked lists which will be finalised on the basis of the common test.

"Any candidate can relinquish his right for appointment in writing duly attested

by a Gazetted Officer of State/Central Government with signature, Name, Designation

and Office Seal along with a notarized affidavit and a self attested copy of an ID Proof

bearing photograph as enlisted in the general conditions. The request for relinquishment

received within 15 days from the date of publication of Ranked List in the official

website of the commission will be honoured against the requisitions of vacancies that are

pending with the Commission upto the finalisation of the Ranked List. After the

publication of the Ranked List, the request for relinquishment will be considered only if

such request is received on or before the date of receipt of requisition, based on which he

is to be advised".
