Applications are invited from qualified candidates belonging to Scheduled Caste Converted to Christianity and OBC Communities of Kerala State for appointment to the under mentioned post. Application must be submitted online through the official website of the Commission after One Time Registration. Candidates who have already registered can apply through their profile.

*Note:-* (i) Separate Ranked lists will be prepared for Thiruvananthapuram, Alappuzha districts in pursuance of this notification. The Ranked list thus prepared and published by the Commission, shall remain in force until candidates are advised and appointed against the vacancies earmarked for the above communities, but remain unfilled due to paucity of candidates during the currency of the Ranked list published for the post in the following Districts or for three years from the date of publishing the NCA Ranked list as per this notification whichever is earlier.

(ii) In the case of change in Caste/Community noted in the SSLC Book, candidates must claim their original Caste/Community in the application and shall produce Non-Creamy Layer Certificate issued by the Revenue Authorities and the Original Gazette notification publishing the change of Caste/Community at the time of OTR verification for the selection to the above post.

(iii) The selection in pursuance of this notification will be made on a revenue district basis, subject to the special conditions laid down in G.O.(MS) No. 154/71/PD dated 27/5/1971. A candidate advised for appointment in one Revenue District from the ranked list prepared is not eligible for transfer to

another district unless he/she completes five years continuous service in the former district. Even if transfer is allowed after five years, it will be subject to the rule in G.O (MS)No.4/61/PD dated 02.01.1961. Candidates already in Government service holding this post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.

5. Method of appointment : Direct Recruitment (From candidates belonging to Scheduled Caste Converted to Christianity ( SCCC) & OBC Communities of Kerala State Only)

**Note:-**Application submitted by candidates belonging to the communities other than those belonging to Scheduled Caste Converted to Christianity ( SCCC) & OBC Community will be summarily rejected. No rejection memo will be issued to these candidates.

- 6 Age Limit 18-39. Only candidates born between 02.01.1980 and 01.01.2001 (both dates included) are eligible to apply for this post. [Including the relaxation as per para 2 (i) of General Conditions].

Note:- (i) *In the case of Adult members of the Scheduled Caste and their children when such adult members are converted to Christianity the age limit will be 18-41, ie Such candidates should be born between 02.01.1978 and 01.01.2001 (both dates included). (including the relaxation as per Para 2(i) of the General conditions)*

(ii) *For concessions allowed in upper age limit, subject to the condition that the maximum age limit shall in no case exceed 50 (fifty) years, please see para (2) of the General conditions under part II of this Notification. (except para 2 (i)*

- 7 **Qualifications** 1) Must have studied up to VIII Standard or its equivalent  
2) Should have good physique and must be free from physical deformity and diseases of any description.

**Note:-** (1) Physical fitness shall be certified by a Medical Officer not below the rank of an Assistant Surgeon

(2) Differently Abled persons are not eligible to apply for the post.

(3) Concessions for Differently Abled candidates contemplated in para 2 and 5 of the general condition are not applicable for selection to this post.

(4) Candidates who claim equivalent qualification instead of qualification mentioned in the Notification shall produce the relevant Government Order to prove the equivalency at the time of verification, then only such qualification shall be treated as equivalent to the qualification concerned.

(5) Rule 10a(ii) of the Part II of KS&SSR will be applicable for this post.

## 8 Mode of submitting Applications:-

Candidates must register as per ONE TIME REGISTRATION scheme through the Official Website of Kerala Public Service Commission [www.keralapsc.gov.in](http://www.keralapsc.gov.in) before applying for the post. Candidates who have already registered can apply by logging in to their profile using their User-ID and password. Candidates must click on the Apply Now button of the respective posts in the Notification Link to apply for a post. The photograph uploaded should be one taken on or after 31/12/2010. Name of the candidate and the date of taking photograph should be printed at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of taking the photograph. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a printout of the application by clicking the link Registration Card in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of application on the profile, candidates must ensure the correctness of the information on their profile. They must quote their User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. The Application will be summarily rejected if noncompliance with the notification is found in due course of processing. Documents to prove Qualification, Experience, Community, age etc. have to be produced as and when called for. **Candidates who have Aadhar Card should add Aadhar Card as ID proof in their profile.**

- 9 Last date for receipt of applications : 18.12.2019 Wednesday upto 12 midnight
- 10 If Written Test/OMR/Online Test is conducted as part of this selection, candidates shall submit a confirmation for writing the examination through their One Time Registration profile. Such candidates alone can generate and download the Admission Tickets in the last 15 days till the date of Test. The applications of candidates who do not submit confirmation within the stipulated period will be rejected absolutely. The periods regarding the submission of confirmation and the availability of Admission Tickets will be published in the Examination Calendar itself. Information in this regard will be given to the candidates in their respective profiles and in the mobile phones registered in it. Candidates who have downloaded the Admission Ticket will alone be permitted to attend the examination.
