The duly filled in application in the prescribed form (available from the commission's website <a href="https://www.keralapsc.gov.in">www.keralapsc.gov.in</a>) along with the original chalan should be submitted to the District Officer, K.P.S.C District Office, Ernakulam ,682016 within 45 days from the date on which this Ranked List is uploaded in the Commission's Website. A copy of an answer sheet will be issued only once to a candidate. Candidates are prohibited from applying for copy of an answer sheet which is not their own, and legal proceedings will be initiated against those who do so.
