NOTIFICATION

The following is the Ranked List of candidates found Suitable by the Commission on the basis of the Objective Type (OMR) Test held on 07.02.2018 for selection to the post of Lineman (Electrical wing) on Rs 9940-16580/-(PR) in Public Works Department in Wayanad District (Cat. No 281/2017) notified in the Gazette dated 18.08.2017 and arranged in the order of merit. The Ranked List is brought into force with effect from 3.12.2019.

The Ranked List Shall remain in force for a minimum period of one year, subject to the condition that the said list will continue to be in force till the Publication of a new Ranked List after the expiry of the minimum period of one year or till the expiry of three years whichever is earlier. Candidates from this list will be advised for appointment against vacancies reported to the Commission during the pendency of the list. As the advice for appointment depends on the occurrence of vacancies, there is no guarantee that all candidates included in the list will secure appointment. The candidates remaining in the List at the time of cancellation will have no claim at all, for appointment on the basis of the inclusion of their names in the list.

According to the existing procedure, revaluation of Answer Script is not allowed. A period of 45 days time to apply for rechecking of Answer Scripts will be allowed to candidates with effect from the date on which this Ranked List is The candidates can avail only one uploaded in the Commission's website. chance."Applications for rechecking of answer scripts should be submitted in the prescribed form available free of cost from the Enquiry Sections of the various offices of the Commission or its photocopy, or downloaded and printed in A4 size paper from the Commission's Website www.keralapsc.gov.in or photocopied there from. Applications submitted in any other manner will not be considered. "The application for rechecking, along with original chalan receipt for the prescribed fee of Rs.85/-under the head of account "0051 - PSC 105 State PSC 99 - Examination Fee", addressed to The District Officer, Kerala Public Service Commission District Office Wayanad should reach the office within 45 days from the date on which this ranked list is uploaded in the Commission's website. Application for rechecking received after the stipulated time will not be entertained and fee once remitted will not be refunded.

Candidates who wish to obtain a photocopy of their OMR answer sheet (Part A & Part B) relating to this selection shall remit the fee

of Rs.335/- in any of the Treasuries in the State (Head of account: 0051PSC-800-State PSC-99 other receipts). The duly filled in application in from the Commission's form (available prescribed www.keralapsc.gov.in) along with the original chalan should be submitted to The District Officer, kerala Public Service Comission District office wayanad within 45 days from the date on which this Ranked list is uploaded in the Commission's A copy of an answer sheet will be issued only once to a candidate, Candidates are prohibited from applying for a copy of an answer sheet which is not their own, and legal proceedings will be initiated against those who do so. The last date for receipt of applications within 45 days from the date on which this Ranked list is uploaded in the Commission's website. Applications received after the prescribed date will not be entertained.

Entries put in Column 8 (Community) are based on the communities specified by the candidates in their application forms and proved by them with necessary documents. The candidates whose communities have not been correctly noted in the list as proved by them in their applications should intimate the fact to the District Officer, Kerala Public Service Commission District Office, Wayanad with in 1 (one) month from the date of publication of the Ranked list to get the benefit of reservation to which they are entitled to. In the absence of timely in formation regarding discrepancies, if any, the candidates will be advised as incorporated in the Ranked List.

"Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/Central Government with signature, name, designation and office seal along with a notarized affidavit and a self attested copy of an ID proof bearing photograph as enlisted in the General Conditions. The request for relinquishment received within 15 days from the date of publication of Ranked list in the Official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission upto the finalisation of Ranked List. After the publication of the Ranked list, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition based on which he/she is to be advised".

The A Part and B Part of OMR Scripts will be destroyed after completing six months period from the date if finalisation of Ranked list ie, on 02.06.2020.
