Note :- (6) Candidates included in the Short List are required to produce Non Creamy Layer Certificate issued by the Revenue authority at the time of OTR Verification.

Note :- (7) Copy of answer scripts of the OMR Test held on **27-07-2019** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
