NOTIFICATION

The following is the Ranked List of candidates for the post of **LABORATORY ASSISTANT (SR-SC/ST)** in **HIGHER SECONDARY EDUCATION DEPARTMENT** in **Idukki District (Category No. 349/17)** on **₹17,500 ± 39,500/-** found suitable by the Commission and arranged in the order of merit based on the marks secured in the OMR Test held on 10.11.2018. This Ranked List is brought into force with effect from 14.01.2020.

The Ranked List of selected candidates published by the Commission shall remain in force for a minimum period of one year and a maximum period of three years provided that the said list will not continue to be in force if a new list after the expiry of minimum period of one year is published. Candidates from the list will be advised for appointment in accordance with the rules and orders regarding reservation and rotation as amended from time to time, if applicable, against vacancies reported to the Commission during the pendency of the list. As the advice for appointment depends on the occurrence of vacancies, there is no guarantee that all candidates included in the list will secure appointment. The candidates remaining in the list at the time of cancellation will have no claim at all, for appointments on the basis of the inclusion of their names in the list.

Recruitment will be made for the vacancies reported for Special Recruitment from Scheduled Castes/Scheduled Tribes during the pendency of the list. Candidates against vacancies reported exclusively for Scheduled Tribes will also be advised from this list and only in the absence of Scheduled Tribe candidates in this list, fresh notification for vacancies reserved exclusively for Scheduled Tribes will be issued.

NOTE I:

Candidates who wish to obtain a photocopy of their OMR Answer sheet (Part A & Part B) relating to this selection shall remit the fee of **₹ 335/- (Rupees Three hundred and thirty five only)** in any of the treasuries in the State (Head of Account **0051-PSC-800 State PSC ± 99 other receipts**). The duly filled in application in the prescribed form (available from the Commission's website www.keralapsc.gov.in) along with the original chalan should be submitted to the **District Officer, KPSC District Office, Idukki, Kattappana -685508 within 45 days from the date on which this Ranked List is uploaded in the Commission's website.** A copy of the answer sheet will be issued only once to a candidate. Candidates are prohibited from applying for a copy of an answer sheet which is not their own, and legal proceedings will be initiated against those who do so. The last date of applications is **21.03.2020**. Applications received after the prescribed date will not be entertained.

NOTE II:

A period of 45 days time to apply for rechecking of Answer Scripts will be allowed to candidates **with effect from the date on which this Ranked List is uploaded in the Commission® web site.** The candidates can avail only one chance. ^aApplications for rechecking of answer scripts should be submitted in the prescribed form available free of cost from the Enquiry Sections of the various offices of the Commission or its photocopy, or downloaded and printed in A4 size paper from the Commission® Website www.keralapsc.gov.in or photocopied there from. Applications submitted in any other manner will not be considered^o

The application for re-checking, along with original chalan receipt for the prescribed fee of Rs.85/- under the head of account **^a0051-PSC 105 State PSC 99 ± Examination Fee^o, addressed to The District Officer, Kerala Public Service Commission District Office, Kattappana, Idukki ± 685508** should reach the office on or before **21.03.2020, within 45 days from the date on which this Ranked List is uploaded in the Commission® website.** Application for rechecking received after the stipulated time will not be entertained and fee once remitted will not be refunded.

NOTE III:

^aAny candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/Central Government with signature, Name, Designation and Office Seal, along with an affidavit from NOTARY PUBLIC and self attested copy of ID proof bearing photograph as enlisted in the General Conditions. The request for relinquishment received within 15 days from the date of publication of the Ranked List in the Official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission upto the finalisation of the Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised^o.

The A Part and B Part of OMR Scripts will be destroyed after completing six months period from the date of finalisation of Ranked List ie, **13.07.2020.**
