NOTIFICATION

The following is the Ranked List of candidates for the post of **LABORATORY TECHNICIAN in HEALTH SERVICES DEPARTMENT in Thrissur District (Cat. No: 007/2018) on Rs. 22200-48000/-** found suitable by the Commission and arranged in the order of merit based on marks secured in the OMR test held on 07.07.2018. **This Ranked List is brought into force with effect from 26.03.2020.**

The Ranked List will remain in force till the publication of a new Ranked List after the expiry of a minimum period of one year or till the expiry of 3 years whichever is earlier. Candidates from this list will be advised for appointment in accordance with the Rules and Orders regarding reservation and rotation as amended from time to time, if applicable, against vacancies reported to the Commission during the pendency of the List. As the advice for appointment depends on the occurrence of vacancies, there is no guarantee that all candidates included in the list will secure appointment. The candidates remaining in the List at the time of cancellation will have no claim at all for appointment on the basis of the inclusion of their names in the List.

The entries put in column 8 are based on the communities specified by the candidates in their profile and proved by them with necessary documents. The candidates whose communities have not been correctly noted in the ranked list as proved by them in their applications and Profile should intimate the fact to **The District Officer, Kerala Public Service Commission District Office, Thrissur-680020** within 1(one) month from the date of publication of the Ranked list, to get the benefit of reservation to which they are entitled to. In the absence of timely information regarding discrepancies, if any, the candidates will be advised as incorporated in the list.

NOTE 1:

Candidates who wish to obtain a photocopy of their OMR answer sheet(Part A and Part B) relating to this selection shall remit the fee of **Rs. 335/-** in any of the Treasuries in the **State (Head of account 0051 PSC -800-State PSC-99** other receipts). The duly filled in application in the prescribed form (available in the

Commission's website www.keralapsc.gov.in) along with the original chalan should be submitted to the District Officer, K.P.S.C District Office, Thrissur-680020 within **45(forty five) days** from the date on which the Ranked List is uploaded in the Commission's website. A copy of the answer sheet will be issued only once to a candidate. Candidates are prohibited from applying for a copy of answer sheet which is not their own, and legal proceedings will be initiated against those who do so. Application received after the prescribed time limit and not in the prescribed form will not be entertained.

NOTE II:

A period of 45 days time to apply for rechecking of Answer Scripts will be allowed to candidates with effect from date on which this Ranked list is uploaded in the Commission's website. The candidate can avail only one chance. Applications for rechecking of answer scripts should be submitted in the prescribed form available free of cost from the enquiry sections of the various offices of the Commission or its photocopy or downloaded and printed in A4 size paper from the Commission's website:www.keralapsc.gov.in or photocopied there from. Applications submitted in any other manner will not be considered.

The application for re-checking along with the original chalan receipt for the prescribed fee of Rs. **85/- (Rupees Eighty Five only)** under the Head of Account **“0051 PSC 105 State PSC-99 Examination Fee”**, addressed **to the District Officer, Kerala Public Service Commission District office Thrissur- 680020** should reach the office within 45 days from the date on which this Ranked List is uploaded in the Official Website of the Commission. Application for rechecking received after the stipulated time limit will not be entertained and fee once remitted will not be refunded.

NOTE III:

“Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/Central Government with signature, name, designation and Office seal along with a notarized affidavit and self attested copy of ID proof bearing photograph as enlisted in the general conditions.” The request for relinquishment received within 15 days from the date of publication of Ranked List in the official web site of the commission will be honoured against the requisitions of vacancies that are pending with the Commission upto the finalisation of Ranked List. After the publication of the Ranked List, the request of relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he /she is to be advised.

NOTE IV:

A part and B part of the OMR script will be destroyed after completing 6 months period from the date of finalisation of the Ranked List that is on 25.09.2020.
