**NOTIFICATION**

The following is the list of candidates found suitable by the Commission on the basis of the marks secured in the Objective Type (OMR) Test held on 07.07.2018, for selection to the post of Laboratory Technician Gr.II on ₹22200-48000/- in Health Services Department in Ernakulam District and arranged in the order of merit. The Provisional Ranked List is brought into force with effect from 26.03.2020.

The Provisional Ranked List thus published shall remain in force for a minimum period of one year, subject to the condition that the said list will continue to be in force till the publication of a new list after the expiry of the minimum period of one year or till the expiry of three years whichever is earlier. Candidates from this list will be advised for appointment in accordance with the rules and orders regarding reservation and rotation as amended from time to time, if applicable, against vacancies reported to the Commission during the pendency of the list. As the advice for appointment depends on the occurrence of vacancies, there is no guarantee that all candidates included in the list will secure appointment. The candidates remaining in the list at the time of cancellation will have no claim at all for appointment on the basis of the inclusion of their names in the list.

The entries put in column 8 are based on the communities specified by the candidates in their application forms and proved by them with necessary documents. The candidates whose communities have not been correctly noted in the list as proved by them should intimate the fact to the District Officer, Kerala Public Service Commission District Office, Ernakulam within one month from the date of publication of the list to get the benefit of reservation to which they are entitled to. In the absence of timely information regarding discrepancies, if any, the candidates will be advised as incorporated in the list.

**Note: 1**

Candidates who wish to obtain a photocopy of their OMR answer sheet (Part A and Part B) relating to this selection shall remit the fee of ₹. 335/- in any of the Treasuries in the State (Head of account 0051 PSC -800-State PSC-99 other receipts). The duly filled in application in the prescribed form (available in the Commission's website [www.keralapsc.gov.in](http://www.keralapsc.gov.in)) along with the original chalan should be submitted to the District Officer, KPSC District Office, Ernakulam within 45 (forty five) days from the date on which the Provisional Ranked List is uploaded in the Commission's website. A copy of the answer sheet will be issued only once to a candidate. Candidates are prohibited from applying for a copy of answer sheet which is not their own, and legal proceedings will be initiated against those who do so. Application received after the prescribed time limit and not in the prescribed form will not be entertained.

**Note: II**

A period of 45 days time to apply for rechecking of Answer Scripts will be allowed to candidates with effect from date on which this Ranked List is uploaded in the Commission's website. The candidate can avail only one chance. Applications for rechecking of answer scripts should be submitted in the prescribed form available free of cost from the enquiry sections of the various Offices of the Commission or its photocopy or downloaded and printed in A4 size paper from the Commission's [website www.keralapsc.gov.in](http://www.keralapsc.gov.in) or photo copied there from. Applications submitted in any other manner will not be considered.

The application for re-checking along with the original chalan receipt for the prescribed fee of ₹. 85/- (Rupees Eighty Five only) under the Head of Account “ 0051 PSC 105 State PSC-99 Examination Fee”. addressed to the District Officer, Kerala Public Service Commission District Office, Ernakulam 682016 should reach the Office within 45 days from the date on which this Ranked List is uploaded in the Official website of the Commission. Application for rechecking received after the stipulated time limit will not be entertained and fee once remitted will not be refunded
