Date, Time and Venue of certificate verification of candidates included in this Short List will be intimated in due course.

Note :- (4) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (5) Candidates included in the Short List are required to produce Community Certificate in Form III or digitally signed by the revenue authorities not below the rank of Tahsildar along with the other documents mentioned above at the time of verification of original documents.

Note :- (6) Copy of answer scripts of the OMR Test held on **27-07-2019** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
