NOTIFICATION

The following is the Ranked List of candidates for selection to the post of **BEAT FOREST OFFICER(KANNUR) (PART-I DIRECT RECRUITMENT) (Category No. 582/2017)** in **FOREST DEPARTMENT** in Kannur District on **₹20,000 – 45,800/-** found suitable by the Commission and arranged in the order of merit based on OMR Test held on 07.04.2018, Endurance Test held on 15.10.2019 and 16.10.2019 and Physical Measurement and Physical Efficiency Test held on 19.12.2019 and 20.12.2019 This Ranked List is brought into force with effect from **17.03.2020**.

Note (1):- Since a common OMR test with common candidates was conducted for this post, the marks awarded to the candidates included in the Rank list and mark of OMR Test relating to all candidates appeared for the Test will be published only after the publication of entire Ranked List (including NCA Notification) which will be finalised on the basis of the common test. The result of rechecking of answer script will be intimated in due course. But Photocopy of the OMR answer script will be issued only after the publication of the Ranked List for the all Posts finalised on the basis of the common test.

Note (2):-The Ranked List will remain force till the publication of a new ranked list after the expiry of a minimum period of one year or till the expiry of three years whichever is earlier. Candidates from the Ranked list will be advised for appointment in accordance with the rules and orders regarding reservation and rotation as amended from time to time, if applicable, against vacancies reported to the commission during the pendency of the list. As the advice for appointment depends on the occurrence of vacancies, there is no guarantee that all candidates included in the Ranked list will secure appointment. The candidates remaining in the list at the time of cancellation will have no claim at all for appointment on the basis of the inclusion of their names in the list.

Note (3):- According to the existing procedure, revaluation of answer script is not allowed. But answer scripts will be re-checked if the candidates apply for the prescribed application form available free of cost from the Enquiry Sections of the various offices of the Commission or its photocopy or downloaded and printed in A4 size paper from the Commission's website (www.keralapsc.gov.in) or photocopied there from along with prescribed Fee of **₹. 85/- (Rupees Eighty Five only) under the Head of Account**

“0051- PSC- 105 State PSC 99 Examination Fee”. Examination Fee Addressed to **District Officer, Kerala Public Service Commission District Office, Civil Station PO., Kannur – 670 002.** Application submitted in any other manner will not be considered. A period of 45 days of time for rechecking of answer scripts will be allowed to candidates with effect from the date on which this Ranked List is Uploaded in the Commission’s Website, (ie, on or before 22.07.2020). Application for rechecking received after the stipulated time will not be entertained and Fee once remitted will not be refund.

Note(4):- Candidates who wish to obtain a photocopy of their **OMR Answer sheet (Part A & Part B)** relating to this selection shall remit a fee of ₹. 335/- (Rupees Three hundred and thirty five only) by way of chalan in any of the treasuries in the State under the Head of Account **“0051- PSC-800 State PSC – 99 other receipts”.** The duly filled up application in the prescribed form (available from the Commission’s website **www.keralapsc.gov.in**) along with the original chalan should be submitted to the **District Officer, KPSC District Office, Civil Station PO. Kannur 670 002** within 45(Forty five) days from the date on which the Ranked List is uploaded in the official website of the Commission on or before 22.07.2020). The copy of OMR answer sheet will be issued only once to a candidate. Candidates are prohibited from applying for a copy of answer sheet which is not their own, and legal proceedings will be initiated against those who do so.

Note(5):- The entries put in column 5 are based on the communities specified by the candidates in their application forms and proved by them with necessary documents. The candidates whose communities have not been correctly noted in the list as proved by them in their application should intimate the fact to the **District Officer, Kerala Public Service Commission District Office, Civil Station PO., Kannur – 670 002** within one month from the date of publication of the Rank list to get the benefit of reservation to which they are entitled to. In the absence of timely information regarding discrepancies, if any, the candidates will be advised as incorporated in the list.

Note(6):- **“Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/ Central Government with Signature, Name, Designation and Office Seal along with a notarized affidavit and a self attested copy of an ID proof bearing photograph as enlisted in the General Conditions.”** The request for relinquishment received within 15 days from the date of publication of Ranked List in the official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission up to the finalization of Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised.
