NOTIFICATION

The following is the list of candidates found suitable by the Commission on the basis of the Objective Type (OMR) Test held on 07.04.2018, Endurance Test held from 16.10.2019 to 24.10.2019 and Physical Measurement & Physical Efficiency Test held from 10.12.2019 to 18.12.2019 for selection to the post of **Beat Forest Officer (Direct Recruitment) on Rs.20000- 45800/- in Forest Department in IDUKKI District (Cat No.582/2017)** notified in the Gazette dated 29.12.2017 and arranged in the order of merit. The Ranked List is brought into force with effect from 17.03.2020.

The ranked list shall remain in force for a minimum period of one year, subject to the condition that the said list will continue to be in force till the publication of a new list after the expiry of the minimum period of one year or till the expiry of 3 years whichever is earlier. Candidates from this list will be advised for appointment in accordance with the rules and orders regarding reservation and rotation as amended from time to time, if applicable, against vacancies reported to the Commission during the pendency of the list. As the advice for appointment depends on the occurrence of vacancies, there is no guarantee that all candidates included in the list will secure appointment. The candidates remaining in the list at the time of cancellation will have no claim at all for appointment on the basis of the inclusion of their names in the list.

The entries put in column 8 are based on the communities specified by the candidates in their application forms and proved by them with necessary documents. The candidates whose communities have not been correctly noted in the list as proved by them should intimate the fact to the **District Officer, Kerala Public Service Commission District Office, Idukki, Kattappana P.O, 685508** within one month from the date of publication of the list to get the benefit of reservation to which they are entitled to. In the absence of timely information regarding discrepancies, if any, the candidates will be advised as incorporated in the list.

Since a Common Test/OMR Test with common candidates was conducted for the post, the marks awarded to the candidates included in this Ranked List and marks of OMR Test relating to all candidates appeared for the test will be published only after the publication of entire Ranked Lists (including NCA notifications) which will be finalized on the basis of the common test.

NOTE I:

Candidates who wish to obtain a photocopy of their OMR Answer sheet (Part A & Part B) relating to this selection shall remit the fee of **Rs. 335/ (Rupees Three hundred and thirty five only)** in any of the treasuries in the State (**Head of Account "0051 PSC-800 State PSC - 99 other receipts**). The duly filled in application in the prescribed form (available from the Commission's website www.keralapsc.gov.in) along with the original chalan should be submitted to the **District Officer, KPSC District Office, Idukki, Kattappana 685508 within 45 days from the date on which this Ranked List is uploaded in the Commission's website.** A copy of the answer sheet will be

issued only once to a candidate. Candidates are prohibited from applying for a copy of an answer sheet which is not their own, and legal proceedings will be initiated against those who do so. The last date of applications is **23.07.2020**. Applications received after the prescribed date will not be entertained.

NOTE II:

A period of 45 days time to apply for rechecking of Answer Scripts will be allowed to candidates **with effect from the date on which this Ranked List is uploaded in the Commission's web site**. The candidates can avail only one chance. "Applications for rechecking of answer scripts should be submitted in the prescribed form available free of cost from the Inquiry Sections of the various offices of the Commission or its photocopy, or downloaded and printed in A4 size paper from the Commission's Website www.keralapsc.gov.in or photocopied there from. Applications submitted in any other manner will not be considered.

The application for rechecking, along with original chalan receipt for the prescribed fee of Rs.85/ under the head of account " **0051PSC 105 State PSC-99 - Examination Fee**", **addressed to The District Officer, Kerala Public Service Commission District Office, Kattappana, Idukki - 685508** should reach the office on or before **23.07.2020, within 45 days from the date on which this Ranked List is uploaded in the Commission's website**. Application for rechecking received after the stipulated time will not be entertained and fee once remitted will not be refunded.

NOTE III:

Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/Central Government with signature, Name, Designation and Office Seal, along with an affidavit from NOTARY PUBLIC and self attested copy of ID proof bearing photograph as enlisted in the General Conditions. The request for relinquishment received within 15 days from the date of publication of the Ranked List in the Official website of the Commission will be honored against the requisitions of vacancies that are pending with the Commission up to the finalization of the Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised.

NOTE IV:

The A Part and B Part of OMR Scripts will be destroyed after completing six months period from the date of finalization of Ranked List ie, **16.09.2020**.
