Application for rechecking received after the stipulated time will not be entertained and fee once remitted will not be refunded.

NOTE (III):- "Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/Central Government with signature, name, designation and office seal along with a notarized affidavit and a self attested copy of an ID Proof bearing photograph as enlisted in the General conditions.
