The request for relinquishment received within 15 days from the date of publication of Ranked List in the official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission up to the finalization of the Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised.

NOTE (6)Since a common OMR test with common candidates was conducted for this post, the marks awarded to the candidates included in this Ranked List and marks of OMR test relating to all candidates appeared for the test will be published only after the publication of entire Ranked Lists(including NCA Notifications)which will be finalised on the basis of the common test. The result of rechecking of OMR answers scripts will be intimated in due course. But photo copy of the OMR

answer scripts will be issued only after the publication of the Ranked Lists for all the posts finalised on the basis of the common test.

NOTE (7):- The A part and B part of OMR scripts will be destroyed after completing 6 months period from the date of finalisation of Ranked list.
