Note :- (6) Candidates belonging to Other Backward Classes included in this list are required to upload in their profile and produce in person the Non Creamy Layer Certificate(NCLC) as per GO(P)No. 81/2009/SC/ST/DD dated 26.09.2009 along with other documents at the time of One Time Verification.

Note :- (7) Candidates belonging to SC/ST communities are required to upload in their profile and produce in person the Community Certificate obtained from Revenue Authorities not below the Rank of Tahsildar.

Note :- (8) Copy of answer scripts of the OMR Test held on **21-11-2019** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No :ER IV B(3)192/2020/EW dated 30/11/2020.
